

# CONTINGENCY HOUSING FREQUENTLY ASKED QUESTIONS

## **Q: What is contingency housing?**

A: Contingency housing is temporary housing for students whose Fall 2024 housing is not yet available by their move-in date. This typically affects students living on campus for the summer or those with approved early move-in applications. It may also impact students who need to move out of summer housing before their Fall 2024 move-in date is available or if there is a delay with a building's move-in date.

## **Q: Why do we need contingency housing?**

A: Contingency housing is necessary because living areas are required to be cleaned by facilities in preparation for Welcome Week. For example, housing used by summer residents needs to be cleaned after they move out in August.

## **Q: Where is contingency housing located?**

A: Contingency housing will be provided in a residence hall, specifically in double-occupancy suites.

## **Q: How do I know if I will be placed in contingency housing?**

A: Housing Operations will begin notifying students about potential placement in contingency housing via their GCU email as early as May. Students staying on campus for the summer and those with approved early move-in applications will receive periodic notifications about the possibility of being placed in contingency housing leading up to their move-in date. Official contingency housing placements will be sent two weeks prior to the move-in date.

## **Q: How can I avoid being placed in contingency housing?**

A: All students living on campus for the summer and those approved for early move-in must agree to the terms of contingency housing in their respective applications, as emergencies can prevent a student from moving directly into their Fall 2024 booking. However, students can avoid contingency housing by selecting a fall booking in a building not used during the summer or by adjusting their move-in date.

## **Q: Are other occupancy types available for contingency housing?**

A: All housing placements are based on availability. Residence halls are the only available option for contingency housing.

## **Q: Can I choose where I am placed in contingency housing?**

A: If a student has a request to be placed with a specific roommate in the same suite in contingency housing, they can email [housing@gcu.edu](mailto:housing@gcu.edu). However, there is no guarantee that these requests will be accommodated.

## **Q: Am I being charged for contingency housing?**

A: Contingency housing is provided at no additional cost to the student and is offered as a courtesy.

## Q: When can I move into my fall booking after I move into contingency housing?

A: Housing operations will notify students when they are able to move into their fall bookings. Students should plan to move on the Friday following email notification that their fall booking is ready.
