

# SUMMER HOUSING FREQUENTLY ASKED QUESTIONS

## Q: Why is summer housing only in certain buildings?

A: Due to a large population of returning students moving in early for leadership positions or employment, we need to have our summer students in a space where they can comfortably stay all summer long.

## Q: Can I choose my room when I apply for housing?

A: Yes, self-selection will be available during Step 2 of the Summer 2024 Housing Application.

## Q: Can I live with my friends over the summer?

A: Yes, you can create a roommate pair of two members if you complete Step 1 by the priority deadline. If you have more than one roommate in mind, the self-selection process will allow you to coordinate with your friends to select the same suite suite, pending availability.

## Q: Who can't create a roommate pair?

A: Students who apply for summer housing after the Step 1 priority deadline, April 1, and students moving in on May 3 are not eligible to be a part of a roommate pair. Summer housing availability is limited therefore students can only create roommate pairs (not groups). This allows students to have the best opportunity to choose their living space preference.

## Q: When will I be billed for my summer housing and meal plan?

A: Room and meal plan charges will both be posted to your account the day after they are selected.

## Q: What is required to park on campus for summer?

A: Summer parking passes are required and available for purchase starting April 22. Students are permitted to continue parking according to their spring parking passes until May 5. Parking for students living on campus is the garage on 29th Ave. For more campus parking information, visit the [campus parking webpage](#).

## Q: What if I cannot be there for the move-in at the beginning of summer?

A: If you are unable to make Summer Move-In from May 10 – 13, you need to move all your belongings out by April 29 at noon and email the summer RDs at [SummerRDs@gcu.edu](mailto:SummerRDs@gcu.edu) to schedule a new time to move in. After May 13, appointments are only available Monday – Friday from 9 am – 5 pm and must be made at least 24 hours in advance.

## Q: What do I do with my stuff between Spring Move-Out and Summer Move-In?

A: If you are moving into your summer housing assignment on May 10 – 13, you can leave your belongings in your spring room. If you will not be present May 10 – 13, you need to move all your belongings out by April 29 at noon and move them back during your Summer Move-In appointment.

## Q: When can I move out of my Summer 2024 booking into my Fall 2024 booking?

A: Fall Move-Over will be Aug. 2 – 5. Students should plan to be on campus on those dates. Students whose fall bookings aren't ready by that date will move into contingency housing.

# SUMMER HOUSING FREQUENTLY ASKED QUESTIONS

## **Q: What if I cannot be on campus Aug. 2 – 5 for Fall Move-Over?**

**A:** If you cannot complete Fall Move-Over during Aug. 2 – 5, you need to move all your belongings out before Aug. 5 at noon and select a Welcome Week move-in appointment.

## **Q: What if I do not have a Fall 2024 booking?**

**A:** Students without a Fall 2024 booking will be able to remain in their Summer 2024 booking until noon on Aug. 17.

## **Q: What do I do if I do not currently live on campus for Spring 2024?**

**A:** You will be able to move into your Summer 2024 booking on May 3 from 9 am – noon to specific, limited locations or you can wait until Summer Move-In, May 10 – 13.

## **Q: How will summer housing selection timeslots for Step 2 be assigned?**

**A:** Selection timeslots will be emailed and timeslots are assigned in order of most completed credits to least. If you are in a roommate pair, your group leader should be the person with the earliest Step 1 timeslot.

## **Q: I live in a summer building for Spring 2024; why can I not stay in my spring bed for the summer?**

**A:** Residents are not allowed to continue living in their Spring 2024 bed during the summer semester because it prevents the Facilities department from performing necessary maintenance on the suite. Residents are welcome to select within the same building but cannot stay in their Spring 2024 booking.

## **Q: I selected a bed and then was moved, why?**

**A:** The Summer 2024 Housing Application remains open after housing selection has started. If a Spring 2024 student lives in the suite you selected for summer and they apply for summer housing, that suite will have to be taken off the market. The suite will not be ready for a new summer student to move in during Summer Move-In because the current spring resident will remain in their booking until they move over to their Summer 2024 booking.

## **Q: I am working on becoming eligible for Summer 2024 housing, can I still select a bed?**

**A:** Students who are technically not eligible for summer housing because they are still in the hiring process during selection will be able to select a bed. This does mean that you will be responsible for any housing cancellation fees if for some reason your employment does not go through and you are not in any summer classes. Students who are not eligible for summer housing will have their bookings dropped Friday, May 3.

## **Q: Do I have to select a meal plan for summer?**

**A:** No, meal plans are optional for summer. You can select “No Meal Plan” within the application, or choose a meal plan that works for you.
