SUMMER HOUSING FREQUENTLY ASKED QUESTIONS

Q: Which buildings will be available for Summer Housing?

A: Summer Housing will be available in apartments allocated for returners.

Q: Can I choose my room when I apply for housing?

A: Yes, self-selection will be available during Step 2 of the Summer 2025 Housing Application.

Q: What housing opportunities can I opt into during Step 1?

A: The opportunities that are available for students are based on bed eligibility. Students may be eligible to opt into Express Renewal, Express Selection or Standard Selection. To see what housing opportunities you are eligible for, please review your GCU email.

Q: What is Express Renewal?

A: Express Renewal is the opportunity to select your Spring 2025 bed for Summer 2025. This opportunity is only offered if you have an eligible bed and if you complete Step 1 by the Express Renewal Deadline. If you participate in this opportunity, you will continue to reside in your current room and will not be required to move-out at the end of spring.

Q: What is Express Selection?

A: If you plan to live on campus for the next academic year, you will have the opportunity to Express Select your future bed for Summer. This opportunity is only offered if you hold an academic year bed that is also available for Summer. If you participate in this opportunity, you will not be required to move-out at the end of Summer and can continue residing in your room.

Q: Can I live with my friends over the Summer?

A: Roommate groups and pairs are unavailable during the Summer 2025 Housing Application. If you want to live with your friend(s), you will need to coordinate during the self-selection process to select the same suite (pending availability).

Q: When will I be billed for my Summer Housing and meal plan?

A: Room and meal plan charges will both be posted to your account the day after they are selected.

Q: What is required to park on campus for Summer?

A: Summer parking passes are required and available for purchase starting April 1. Students are permitted to continue parking according to their spring parking passes until May 1. Parking for students living on campus will be in all student garages (no student parking in 33rd Avenue Garage). For more campus parking information, visit the **campus parking webpage**.

Q: What is a Pre-Summer booking?

A: A Pre-Summer booking is for students who are living on campus for spring and moving over to Summer. Pre-Summer bookings will be located in your spring bed, or in Contingency Housing. Students who express renew in the Summer Housing Application will not have a Pre-Summer booking.

Q: What if I cannot be there to move over from Spring to Summer?

A: If you are unable to make Summer Move-In from May 9 – 12, you need to move all your belongings out by April 28 at noon and email Housing Operations at **housing@gcu.edu** to schedule a new time to move in. After May 12, appointments are only available Monday – Friday from 9 am – 5 pm and must be made at least 24 hours in advance.

Q: What do I do with my stuff between Spring Move-Out and Summer Move-In?

A: If you express renewed your bed, you can leave your belongings in your spring room and do not need to move over. If you were not eligible for Express Renewal or did not participate you will be assigned a Pre-Summer booking.

SUMMER HOUSING FREQUENTLY ASKED QUESTIONS

Q: Where will my Pre-Summer booking be located?

A: Students who complete Step 1 by the Summer Priority Deadline will have their Pre-Summer booking located in their current Spring room. Students who do not complete Step 1 by the Summer Priority Deadline will have their Pre-Summer booking located in Contingency Housing (Camelback Hall).

Q: How can I avoid my Pre-Summer booking being in Contingency Housing?

A: You can avoid having your Pre-Summer booking in Contingency Housing by completing Summer Step 1 by the Summer Priority Deadline.

Q: When can I move out of my Summer 2025 booking and into my Fall 2025 booking?

A: Fall Move-Over will be Aug. 1 – 4. You should plan to be on campus on those dates. If your fall booking is not ready or your fall booking and Summer booking do not match, you will move into Contingency Housing.

Q: What if I cannot be on campus Aug. 1 – 4 for Fall Move-Over?

A: If you cannot complete Fall Move-Over during Aug. 1 – 4, you need to move all your belongings out before Aug. 4 at noon and select a Welcome Week Curbside Appointment.

Q: What if I do not have a Fall 2025 booking?

A: If you do not have a Fall 2025 booking, you will move into Contingency Housing during Fall Move-Over Aug. 1 – 4, and will remain in Contingency Housing for the rest of the Summer semester. Students without a fall booking cannot remain in Contingency Housing past Saturday, Aug. 16.

Q: When can I move into Summer Housing if I do not currently live on campus for Spring 2025?

A: You will be able to move into your Summer 2025 booking on Friday, May 2, from 9 am - noon.

Q: How will Summer Housing selection timeslots for Step 2 be assigned?

A: Selection timeslots will be assigned in order of most completed credits to least.

Q: I selected a bed and then was moved — why?

A: The Summer 2025 Housing Application remains open after returner housing selection has started. If a Spring 2025 student lives in the suite you selected for Summer and applies for Summer Housing, that suite will have to be taken off the market. The suite will not be ready for a new Summer student to move in during Summer Move-In because the current spring resident will remain in their booking until they move over to their Summer 2025 booking.

Q: I am working on becoming eligible for Summer 2025 Housing — can I still select a bed?

A: Students who are not eligible for Summer Housing because they are still in the hiring process during selection will be able to select a bed. This means that you will be responsible for any housing cancellation fees if, for some reason, your employment does not go through and you're not otherwise eligible. Students who are not eligible for Summer Housing will have their bookings dropped.

Q: Do I have to select a meal plan for Summer?

A: Yes, meal plans are required for Summer. Please see, the **Housing and Meal Costs page** for more information.
