Student Conduct Process: Frequently Asked Questions for Parents

Q: How can I learn how my student is doing?

A: The best answer is to simply ask your son or daughter directly. The college years are a unique time of maturation for students as they take on new responsibilities. The willingness to share information with you will grow as they mature during this time.

Q: Does the university have any written policies about information from student records that can be shared with parents?

A: Yes. Like other colleges and universities across the country, GCU is subject to a federal law called the Family Educational Rights and Privacy Act (also called FERPA or the Buckley Amendment). FERPA sets privacy standards for student educational records and requires institutions to publish a compliance statement, including a statement of related institutional policies.

Q: Where can I find out more information about FERPA?

Q: How will I be notified if I have violated a Community Standard?

A: You will receive an email via your GCU email address notifying you of a date and time to meet with either a Student Conduct Coordinator or the Student Conduct Board or have a Community Conference. If it is a visitation violation, the email will state your sanctions or next steps. This email will also notify you of what policies you may have violated.

Q: What is the difference between meeting with a Student Conduct Coordinator or meeting with the Student Conduct Board?

A: Minor alcohol violations, escalated roommate conflict, harassment and bullying most often require a meeting with a Student Conduct Coordinator. For other violations, you would meet with a coordinator to discuss what the next steps might be. One of those options might be a Student Conduct Hearing with the Conduct Board.

Q: What if I do not attend my conduct hearing?

A: If you fail to appear before the Student Conduct Board, the board will discuss the sanctions that they feel are appropriate for you. In most cases, you will be given the same sanction as other students who were involved in the same incident. A hold may also be placed on your account until you contact the Student Conduct Office.

Q: What if I was not aware of the policy when I broke it?

A: Every GCU student is responsible for knowing the Community Standards. All residential students have agreed to follow those rules at the time when the housing contract is signed.

Q: Will conduct sanctions appear on my academic transcript?

A: Generally not.

Q: What happens if I do not complete my sanctions?

A: If you fail to complete an assigned sanction by the given deadline as outlined in a sanction letter, a hold will be placed on your academic account and housing account. Making changes to your schedule or your ability to choose housing will not be permitted until the sanctions have been completed. If it is an alcohol or drug violation, then you may receive additional sanctions including a fine. If those still are not complete, you may lose housing at GCU.
